<b>6.4</b>	As required, take responsibility for the rapid and effective application of trained skills in emergencies.
<b>6.5</b>	Occasionally attend to minor accidents, administer appropriate first aid treatment and make accurate, legible records
<b>6.6</b>	Regularly undertake cleaning tasks based on daily rotas, completing all such tasks to the highest standards at all times.
<b>6.7</b>	Regularly replenish food and drink displays, keeping accurate and legible stock records when required
<b>6.8</b>	Provide customers with opportunities to purchase retail items relating to the Turkish Baths experience.
<b>6.9</b>	Regularly check customer areas, to ensure cleanliness and customer satisfaction.

<b>6.10</b>	Conduct daily, weekly and monthly safety checks to the specified level of detail and accuracy.
<b>6.11</b>	Regular assistance in the setting up/down of the facility at the start and end of sessions
<b>6.12</b>	Attend compulsory monthly in house training sessions covering specialist areas such as PXB board extraction
<b>6.13</b>	Periodically, undertake other duties which staff might reasonably be expected to perform
<b>6.14</b>	Undertake pool testing every 2 hours on a rota basis and report anomalies to the Duty Manager
<b>6.15</b>	Assists the Facility's Management with the management and provision of catering facilities where appropriate, including serving on and liaising with offsite caterers.
<b>6.16</b>	Maintain training in relation to Food & Beverage and will hold a current Basic Food Handling Course where possible.
<b>6.17</b>	Monitors stock levels on items relevant to the Turkish Baths operation, provides re order information to the Facility's Management and replenishes stock as appropriate.
<b>6.18</b>	Supports the management team in the training of new team members.
<b>6.19</b>	Regularly provide accurate and detailed information to customers as requested by the customers or management staff.
<b>6.20</b>	Regularly receive verbal customer comments and ensure accurate records are made including encouragement to complete customer satisfaction surveys.
<b>6.21</b>	With correct training and where required, undertake simple treatments relevant to the Turkish Baths Experience.
<b>6.22</b>	When on duty, staff are expected to wear uniform, be well presented and to perform their duties in a professional and effective manner to ensure that all customers and visitors receive the highest quality service at all times.
